

**TERMS AND CONDITIONS FOR AUCTION OF SEIZED LIQUOR OF EXCISE  
DEPARTMENT, DIU**

1. Interested Licensee may submit their highest price for the Indian Made Foreign Liquor (IMFL) put on auction in a sealed cover latest by 5.00 P.M on 27/03 /2026. The inner cover containing quotations and other relevant documents along Earnest Money Deposit (EMD) in Cash should be sealed properly. The quoted price must be higher than the offset price fixed by the Excise Department, Diu. The inner cover should be put in on outer cover and may be deposit to Excise Department, Diu. Both the inner and the outer covers should be superscribed in bold Capital letters **"(QUOTATIONS FOR INDIAN MADE FOREIGN LIQUOR/BEER OF EXCISE DEPARTMENT, DIU)"**.
2. The condition of the Liquor/IMFL can be inspected physically on 12/03 /2026 and 27/03 /2026 between 03.30 P.M. to 04.30 P.M at Excise Department, Diu by contacting Excise Guard Posted at Excise Station, Tel. 02875-252204. Tender forms with terms and conditions for submitting tenders can be downloaded from the Departmental website i.e. <https://ddnexcise.gov.in>
3. The quotation should be accompanied by earnest money i.e. Rs 10,000/- (Rs. Ten thousand only). The EMD should be attached with the quotation letter failing which the quotation shall not be considered at all. If the highest tenderer/successful tenderer accepted by the department fails to deposit the sale price within the prescribed time limit i.e. within 07 working days from the date of intimation to the tenderer(s) declared as highest bidder by the department, his earnest money will be forfeited. In case the offer is withdrawn by any tenderer, the earnest money deposited by him shall be forfeited.
4. EMD of Rs. 10,000/- for the auction of liquor is payable by means of Cash. Offers received without EMD amount shall not be considered at all by this Department.
5. EMD of the successful bidders(s) will be released only after realization of Sale proceeds amount. Earnest money Deposit of the bidders who fail to honor the bid in prescribed time limit shall stand forfeited. No representation in this regard shall be entertained by this Department. EMD of unsuccessful bidder(s) shall be released only after successful completion of the Auction Process.
6. The delivery of the Liquor will be arranged only after the successful bidder submits documentary evidence in support of payment in government treasury or online payment (i.e. Challan issued by the Excise Department).

7. The sold Liquor will be removed by the successful bidder(s) within 7 days from the date of intimation to the tenderer(s) declared as highest bidder. No assistance/transportation will be provided by the Department. Permission to take out the sold IMFL/beer from premises will not be allowed on holidays, Sundays etc.
8. EMD of the bidder rescinding their offer, withdrawing or abrogating after submitting the bid shall stand forfeited. Decision of the Department shall be final in this regard.
9. Department of Excise, Diu reserves the right to reject all or any tender in whole or part without assigning any reasons thereof.
10. EMD of unsuccessful bidder shall be returned maximum within 07 Days from the date of declaration of Highest bidder or successful bidder.
11. The bidder is required to reveal his full name/name of the authorized signatory of the Licensee/name of father, full postal address, telephone number & mobile number.
12. Disputes, if any, arises shall be adjudicate by Deputy Commissioner of Excise, Diu.
13. If the highest quoting licensee fails to honor the bid, the bid will be cancelled & its EMD shall be forfeited. In such an event, an opportunity shall be given to the next highest quoting eligible tenderer (Second highest quoting party) to complete the bid provided it is prepared to accept the prices offered by the Highest quoting party. In case of any dispute, decision of the Department shall be final.
14. Tender form should be signed in ink by the Licensee/authorized signatory only. Photocopy or unsigned quotations or quotations not signed by authorized signatory shall be rejected.
15. Tendering Licensee shall alone be responsible for furnishing any false or wrong information and the consequences or loss thereof.
16. Quotation should be offered in prescribed tender form as given at Annexure-I.
