		An affidavit from continuing partner stating that he/she does not have any objection if the retiring partner is granted permission for retirement/withdrawal from the license.

		B) In case of partnership, subject to the contract between the partners, the firm may stand dissolved (with reference to Section 42 of the Partnership Act, 1932). However, if the contract provides for continuation of the partnership after the death of a partner(s), the living partners shall submit:
		a. An application to the Commissioner of Excise for removal of the name of the deceased.
		b. Death certificate of the deceased.
		c. An affidavit stating that there are no legal heirs/claimant of the deceased OR an affidavit from the all legal heirs stating that they are not interested in getting themselves added in the partnership.

		e. An affidavit from continuing/living partner(s) stating that he/she does not have any objection if the retiring partner is accorded approval for retirement/withdrawal from the license.
